Location

Leven is located approximately 35 miles north east of Edinburgh and 20 miles south of Dundee in the north east of Fife. The town is the main commercial centre in the Levenmouth area of Fife which when Leven is combined with neighbouring Methil, Buckhaven and surrounding villages has a population of around 37,410 people.

Situation

The site itself is located on a prominent roadside setting on School Lane to the immeddiate east of Leven's High Street/Durie Street directly north of Lidl. Neighbouring occupiers on Durie Street and the High Street include Leven Library, Greggs, Baynes the Bakers, Specsavers, Iceland Frozen Foods, Superdrug, Farmfoods, Semi-chem and various other national and local retailers. The site is located to the immediate north of Lidl on School Lane, very close to its junction with Durie Street which is a continuation of the town's High Street.

Accommodation

The units will comprise a purpose built, single storey parade comprising 4 units extending to the following approximate areas:

Unit 1	969 sq ft	(90 sq m)
Unit 2	964 sq ft	(89.6 sq m)
Unit 3	964 sq ft	(89.6 sq m)
Unit 4	969 sq ft	(90 sq m)

Please note that these units can be combined and may be sized to occupier's specific requirements.

Lease Terms

Offers are sought from interested parties on the basis of new Full Repairing & Insuring leases for a minimum period of 10 years without breaks.

Timing

The develoment will be completed and available for tenant occupation subject to satisfactory pre-lets being secured.

Planning

A planning application has been made to Fife Council to create the 4 aforementioned units for a Retail Parade with a mix of Class 1 (Retail), Class 2 (Financial) and sui generis (hot food) uses, together with rights over the 29 car parking spaces to be shared with the adjoining former vacant bank building.


