Location

Leven is located approximately 35 miles north east of Edinburgh and 20 miles south of Dundee in the north east of Fife. The town is the main commercial centre in the Levenmouth area of Fife which when Leven is combined with neighbouring Methil, Buckhaven and surrounding villages has a population of around 37,410 people.

Situation

The site itself is located on a prominent corner location on Durie Street lying adjacent to the junction with School Lane. Durie Street is a continuation of the town's High Street. Neighbouring occupiers on Durie Street and the High Street include Lidl, Leven Library, Greggs, Baynes the Bakers, Specsavers, Iceland Frozen Foods, Superdrug, Farmfoods, Semichem and various other national and local retailers.

Accommodation

The unit comprises the ground floor of a former bank building within a substantial two storey detached sandstone building which will share a car park with dedicated spaces (up to 10 spaces subject to agreement) allocated to the unit. The upper floors will be sub-divided which ultimately will result in the unit extending to the following gross internal area:


