## Location

Dalgety Bay is a small but expanding affluent commuter town with a population of circa 10,000 people situated on the north banks of the Firth of Forth approximately 5 miles south east of Dunfermline and 13 miles to the west of Kirkcaldy, 15 miles from Edinburgh and 3 miles from the Queensferry Crossing and Forth Rail Bridge within the Kingdom of Fife.

The subjects themselves are situated in the town's commercial hub within the shopping centre which is anchored by a Tesco Metro. Other occupiers within the centre include **RS McColl, Debra, Rowlands Pharmacy, Barnardos Children, Your Move, The Glass Slipper, Highland Kilt Connections, Barnardos** and **Regents Dental Practice**. In addition the centre has **Hugos Café Bar** located at the edge of the car park. **The Police Station, NHS surgery and clinic** and **local library** are all located to the immediate south of the development. The centre itself benefits from excellent free parking facilities for up to **170 vehicles**.

## Accommodation

The premises comprise a single storey terraced shop/Class 2 unit with excellent display window to the front, previously fitted out as a bank. We calculate that the unit extends to the following approximate floor areas and dimensions:

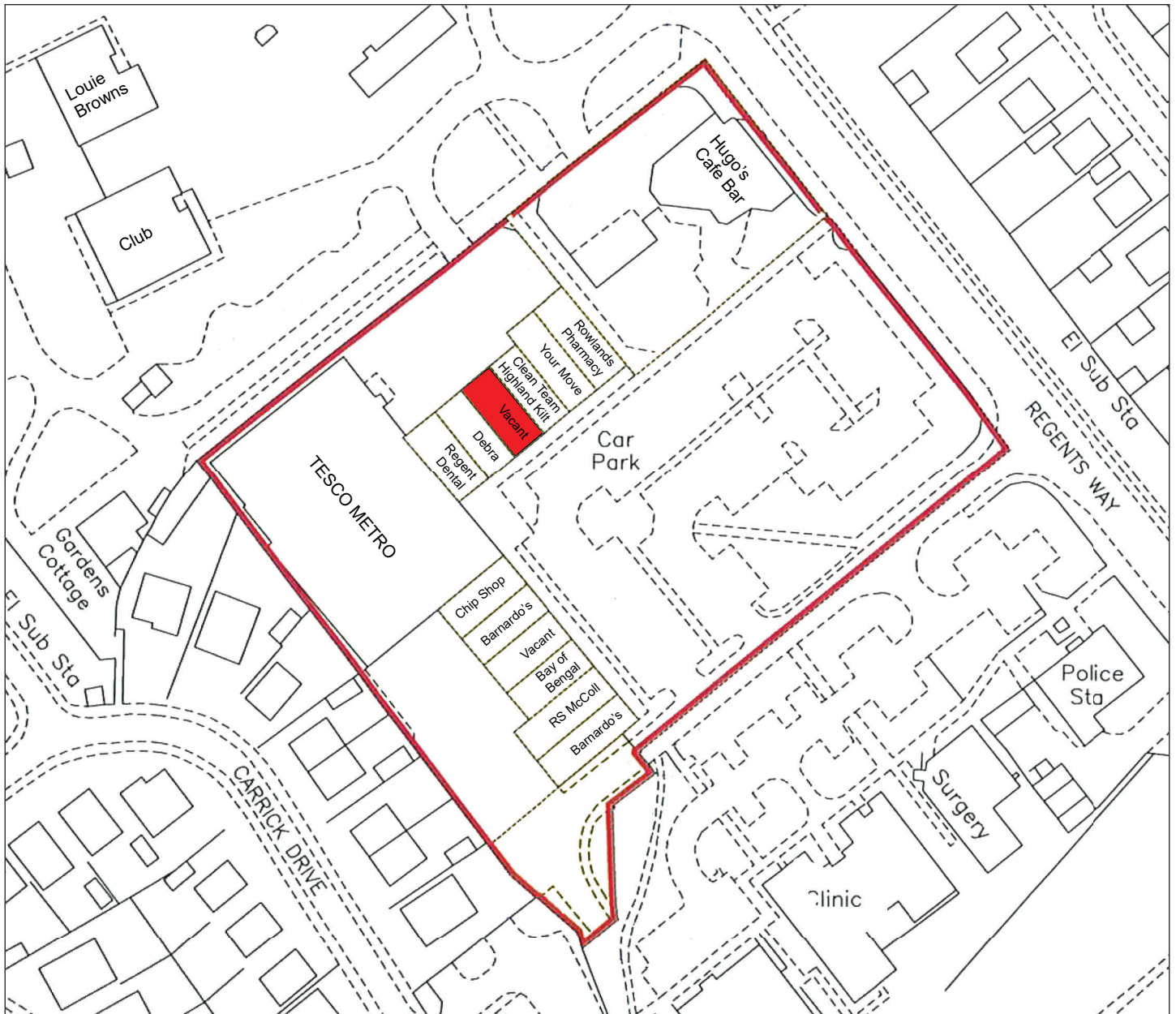
