LOCATION

Falkirk is a thriving town in the central belt of Scotland, lying approximately 25 miles west of Edinburgh and 23 miles north east of Glasgow. The town has a resident population in excess of 35,000 people and serves an estimated catchment of 160,000 within a 6 mile radius.

The Howgate Shopping Centre in Falkirk is firmly established as the prime retail pitch in the town located within the heart of the pedestrian High Street. The shopping centre currently has a strong mix of retailers with surrounding occupiers including **Wilkinsons, Boots, Chisolm Hunter, Clintons** and **Watts**.

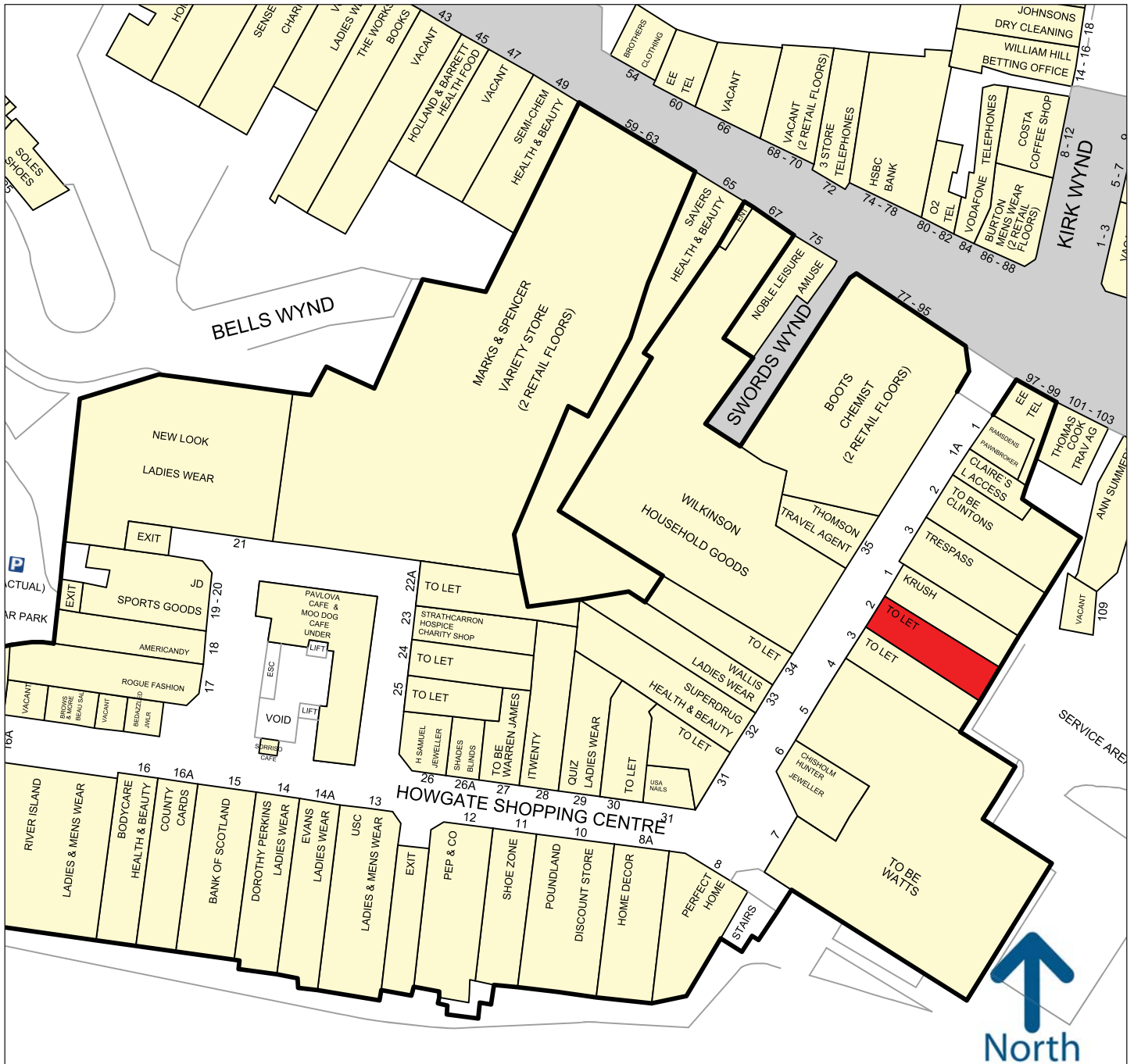
