Location

Stirling is a major regional centre in the central belt of Scotland with a catchment of 115,000 people living within 15 minutes. The town is situated approximately 40 miles from Edinburgh and 35 miles from Glasgow.

The Thistles Shopping Centre provides more than 500,000 sq ft of quality retail space with key anchor stores including **Marks and Spencer**, **Debenhams**, **Boots** and **Primark**.

The property is located in Marches Mall with nearby retailers including **Primark**, **Yours Clothing** and **O2**.

Accommodation

The property comprises a retail unit over ground and first floor levels. The property extends to the following approximate net internal areas:

We have been verbally advised by the Rates Authority that the rateable value of the subjects with effect from 1 April 2017 is **£57,500**. (Each new occupier has the right of appeal against this figure).

Based on a rate poundage of 49p, (plus large property supplement of 2.6p) this rateable value will result in an estimated rates liability in financial year 2019/20 of **£29,670**.

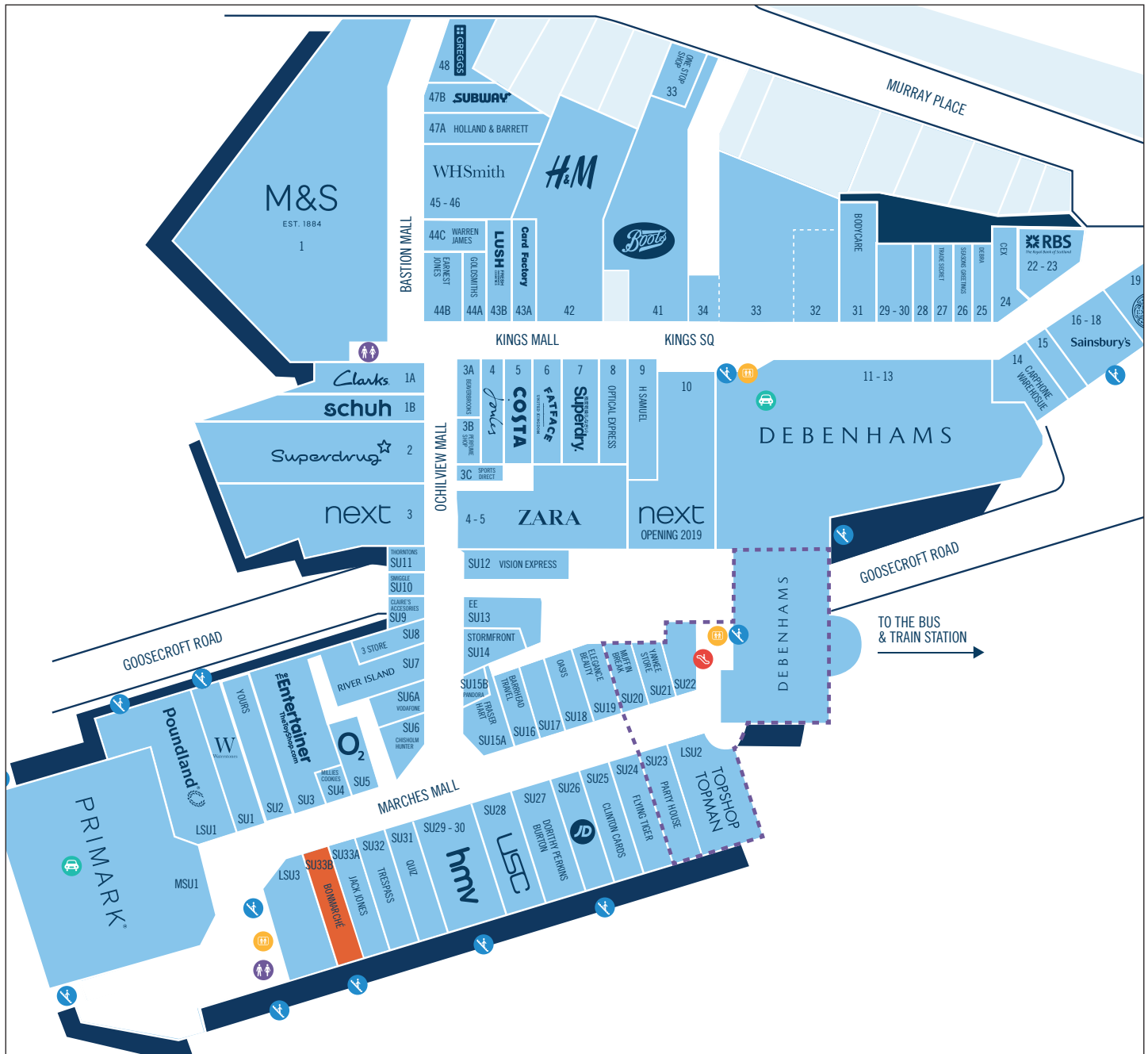
